# First-Timer for 69th NAPS National Convention

I recently had the privilege of attending the 69th National Association of Postal Supervisors (NAPS) Convention at Foxwoods Resort Casino in Connecticut. It was my first time participating in this prestigious event, and I wanted to take a moment to share my profound experiences and reflections.

The convention opened with a newcomers' orientation, which set the tone for the week. During this session, we were introduced to the parliamentary process in an unexpected yet incredibly enlightening way—through the "pizza parliamentarian process" guide. I was amazed to learn how such a simple concept as ordering pizza among friends could be used to explain parliamentary procedures. This engaging analogy helped me understand the complexities of parliamentary procedures in a straightforward, relatable manner. I found this to be one of the most profound educational moments during the convention.

The opening ceremony was equally impressive, with appearances from prominent guests such as Postmaster General Louis DeJoy and a video message from Connecticut Senator Richard Blumenthal. Their affirmations of support for the U.S. Postal Service were inspiring, as they emphasized the critical role, we all play in maintaining the vitality of this essential institution. Witnessing these figures lend their voices to our cause was an eye-opening experience for me, reinforcing the importance of our work and our unity as postal supervisors.

Throughout the convention, the process of adopting new amendments for the bylaws and resolutions was another significant learning curve. It became clear to me that NAPS is truly an association of the current and retired EAS employees, where members have the opportunity to propose amendments to the current bylaws and have them voted on by their peers. Not only can members propose changes, but they can also publicly voice the reasoning behind their amendments, fostering a culture of open dialogue and collective decision-making. This democratic process underscored the inclusivity of NAPS, making me realize how important it is for each of us to engage actively in shaping the future of our association.

One of the highlights of the convention was the vote to determine the location of the 71st NAPS Convention in 2028. The two finalists were the Grand Sierra Resort in Reno, NV, and Harrah's Resort in Atlantic City, NJ. Since the 70th convention is set to be held in San Francisco, CA, I initially thought Atlantic City would be a more cost-effective option for the following year. However, the majority of members voted for Reno as the host city, which reminded me of the strength and inclusiveness of our collective decision-making process. As we discussed future conventions, I couldn't help but reflect on the fact that NAPS held its 17th convention in Minneapolis, MN, back in 1924—exactly 100 years ago. I hope we'll have the chance to bring the convention back to Minnesota in the future.

I also want to express my gratitude to the auxiliary team members who worked tirelessly behind the scenes to ensure that the convention ran smoothly. Their support, both logistical and financial, was invaluable to the success of the event. A special thank you also goes out to the group of sergeants-at-arms, who played a crucial role in maintaining order throughout the convention. I was delighted to see familiar faces like Gina Hellermann and Mark Hellermann from our branch serving as part of this team, and I want to thank them personally for their dedication and hard work.

The sponsors were also an integral part of the convention's success. As the legislative representative for Branch 16, I would be remiss if I didn't take this opportunity to talk about one of the key legislative initiatives. Reps. Garrett Graves (R-LA) and Abigail Spanberger (D-VA), sponsors of H.R. 82, the Social Security Fairness Act, announced plans to file a "discharge petition" after Congress returns from its August recess. With 218 signatures, this petition could force a House vote on the bill. As of August 26, 2024, H.R. 82 has 325 cosponsors and seeks to repeal the Government Pension Offset (GPO) and Windfall Elimination Provision (WEP), which reduce Social Security benefits for public employees, including those in the Civil Service Retirement System (CSRS). I strongly urge our branch members to contact their representatives and encourage them to sign this petition to advance the bill. **Scan the QR code** below on this page to log in and send your message.

For those who haven't had the opportunity to attend a NAPS convention, I highly encourage you to participate in the next one in San Francisco in 2026. The experience is truly invaluable, offering both education and camaraderie that will deepen your connection to NAPS and its mission. All you have to do is attend your branch meeting every other month and you will qualify to attend the next NAPS 70<sup>th</sup> Convention.

# President Biden Nominates Gordon Hartogensis, former Director of Pension Benefit Guarantee Corporation, to Postal Board of Governors

On September 9, President Biden nominated former director of the Pension Benefits Guarantee Corporation (PBGC) Gordon Hartogensis, to succeed Ramon Martinez IV on the U.S. Postal Board of Governors. Martinez's term expires on December 8, 2024. Hartogensis served as director of the PGBC from 2019 to 2024. His term expired in April 2024. The PGBC is a federally chartered corporation tasked with encouraging the continuation and maintenance of voluntary private defined benefit pension plans. Hartogensis is also the brother in-law of Senate Republican Leader Mitch McConnell (R-KY).

With his most recent nomination, in 2024, President Biden has submitted to the U.S. Senate for confirmation to the Postal Board: former Secretary of Labor Martin Walsh (D), former Congresswoman Val Demings (D), former Postal Governor William Zollars (R) and Gordon Hartogensis (R). If the Senate confirms all four, the Board would be comprised of four Democrats (Ronald Stroman, Daniel Tangerhlini, Martin Walsh and Val Demings), four Republicans (Robert Duncan, Derek Kan, William Zollars and Gordon Hartogensis), and one Independent (Amber McReynolds). Moreover, the only remaining Trump nominee would be Duncan, whose term expires in December 2025.

## How do I receive credit for sponsoring/recruiting a new NAPS member?

If you are recruiting a new NAPS member who is an active employee of the Postal Service, please include your personal information at the bottom of the Form 1187 of the member you are sponsoring. The Form 1187 includes a section, NAPS SPONSOR, at the end of the form to record your information as the recruiter. Please include your full name, branch number, and mailing address in the NAPS SPONSOR section. When NAPS HQ receives the Form 1187 of a new member, as the sponsor, you will receive a \$25.00 check in the mail. Please allow up to 30-45 days to receive your sponsor award (\$25 check).

You must be an active Regular or Associate member of NAPS in order to be credited as a NAPS recruiter. To be a sponsor, you do not have to be affiliated with the same branch where the new member is joining. Only one sponsor can be listed for each newly recruited NAPS member. If an employee is already a NAPS member, and a duplicate Form 1187 is submitted to our headquarters on their behalf, NAPS HQ cannot credit a second recruiter. If the NAPS SPONSOR section of the Form 1187 is left blank NAPS HQ understands that there was no local recruiter for the application. Executive Board members may be listed as NAPS SPONSORS, but will not receive a sponsor check. NAPS Sponsorship is not recorded or credited for the recruitment of new Associate members. On the Request for Associate Membership Form, there is no NAPS SPONSOR section.

## NAPS AUXILIARY MEMBER INVITE

By joining, as a new member, you can directly support your **NAPS** (**National Association of Postal Supervisors**) member using your Auxiliary voice to assist in NAPS legislative initiatives. Auxiliary members also assist at local meetings and support and promote the Supervisor Political Action Committee (**SPAC**) providing financial support, through fund raising at conventions.

Each NAPS member, in good standing, is entitled to **one Auxiliary member** (over 16 years of age) who may be a **spouse**, **immediate family member** *or* **designated representative**. (All Auxiliary dues are paid by the local branch.)
